What is lobbying?

Definition: communicating directly with an official in the executive branch of state government or an official in the legislative branch of state government for the purpose of influencing legislative or administrative action. Mich. Comp. Laws Ann. § 4.415.



What does a lobbyist do?

We Advocate. Lobbying is a type of advocacy.

- **Direct Lobbying:** Meeting with policymakers, providing information, and explaining your position.
- **Grassroots Lobbying:** Mobilizing public support and encouraging citizens to contact their lawmakers.
- **Coalition Building:** Working with other organizations and individuals who share similar goals.
- **Providing Information:** Conducting research, preparing reports, and sharing data with policymakers.

What does a lobbyist do (continued)?

Identify Goals: *What is the issue?* Clearly define the specific policy outcomes you aim to achieve.

Build Relationships: Establish and cultivate relationships with policymakers, their staff, and other interested parties.

Craft Strategy: Determine which elected officials or government agencies are most relevant to your issue and should be the focus of your lobbying efforts.

What type of organizations use lobbyists?

All of them... We can make the case for anything. Try us.

- *Corporations*
- *Nonprofits*
- *Federal, State, and Local Governments*
 - *Government Agencies*

Multi-client vs. Association/In-house

What does your SFAD lobbyist also do?

- **Follow member-developed Core Principles and Legislative Agenda.**
- **Testify before legislative committees.**
- **Prep you to testify before committees.**
- **Provide information for you to talk with legislators.**
- **Staff five internal issue committees.**

The League's internal policy committees

Led by members.

The committees review legislation and recommend policy positions to be approved by the League's Board of Trustees.

Internal Policy Committees:

- **Municipal Finance**
- **Municipal Services**
- **Economic Development & Land Use**
- **Energy & Environment**
- **Transportation, Infrastructure, and Technology**

What issues do we review?

A few examples...

- Municipal Finance: Revenue sharing, personal property tax, pension and OPEB.
- Municipal Services: FOIA, OMA, local permitting, law enforcement, emergency response, labor, elections.
- Economic Development & Land Use: Housing, zoning, and economic incentives.
- Energy & Environment: Municipal electric utilities, renewable energy, emerging contaminants, recycling, materials management.
- Transportation, Infrastructure, & Technology: Roads, bridges, multimodal transportation, water, sewer, stormwater, telecommunications, and broadband.

What should a lobbyist know?

How a bill becomes a law.

Beginning In the House

- Step 1: Bill Introduction
- Step 2: Referral to Committee
- Step 3: Committee Hearings
- Step 4: Committee Sends to House Floor
- Step 5: Second Reading
- Step 6: Third Reading
- Step 7: Transmit Bill to the Senate

Transmitted to the Senate

- Step 1: Senate Receives, Refers to Committee
- Step 2: Committee Hearings
- Step 3: Committee Sends Bill to Senate Floor
- Step 4: General Orders
- Step 5: Third Reading
- Step 6: Bill Returned to House
- Step 7: House Enrolls and sends to the Governor

What SFAD wants you to know

The Michigan Legislature

It makes decisions daily that impact communities.

- 4,000 bills introduced each session (on average).
 - 2/3 will affect your municipality.
- Michigan is one of only a handful of states with a true full-time legislature.
- You have year-round access to your state legislators.

  **House Introduced Bill**
Introduced bills appear as they were introduced and reflect no subsequent amendments or changes

  **As Passed by the House**
The As Passed by the House version is the bill, as introduced, that includes any adopted House amendments

  **As Passed by the Senate**
The As Passed by the Senate version is the bill, as introduced, that includes any adopted Senate amendments

  **House Concurred Bill**
The Concurred Bill is the version passed in identical form by both houses of the Legislature, issues prior to availability of the Enrolled Bill

  **Public Act**
A Public Act is a bill that has become law

What SFAD wants you to know (continued...again)

A day in the life of a legislator.

- They face hundreds of issues daily, a majority of which are complex, and they may have little background in.
- They rely heavily on their own staff and caucus staff.
- They are always at work, whether in district or Lansing.
- In the age of term limits, lobbyists are also educators.

What SFAD wants you to know (one more time...)

Building relationships is critical.

- Make it a priority to develop relationships and talk with your legislators.
- Meet with them in district.
 - Invite them to events.
 - Let them know your priorities.
- Build relationships with their staff.
