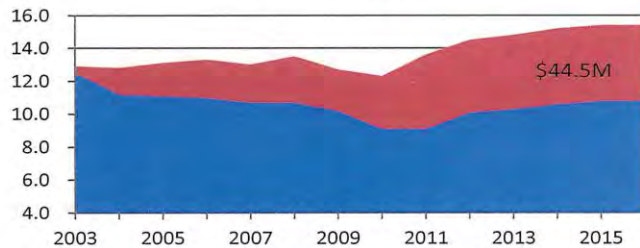

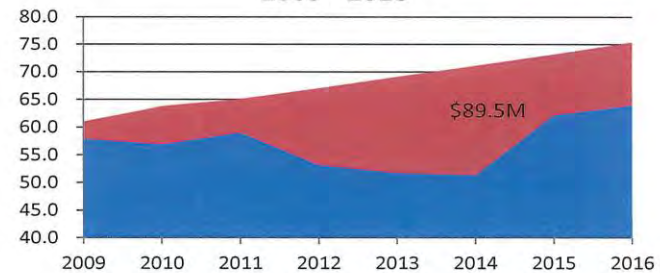

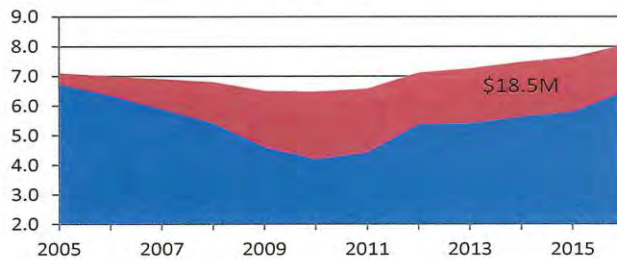
**Cumulative Revenue Sharing Loss
2003 - 2016**



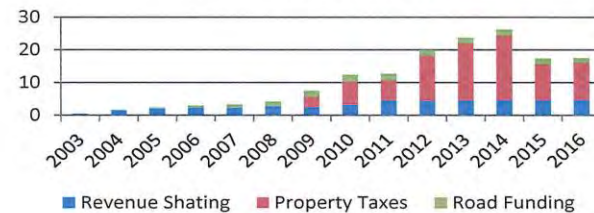
**Cumulative Property Tax Loss

Pension and Retirement Benefit Reform

RETIREE HEALTH CARE:

- Retirees that have health care will have to pay increased deductibles, co-pays and premium sharing. Health care may also change in retirement.
- New hires do not receive retiree health care.
- Approximate \$50 million in actuarial savings over time.

Pension and Retirement Benefit Reform

RETIREMENT PENSION SAVINGS:

DEFINED BENEFIT

- Increased employee contribution from 5% to 8% of wages.
- Multiplier reduced from 2.3% to 2% for service earned on and after July 1, 2013.
- 80% reduction in leave banks paid out that are utilized in pension calculations reduced pension by 10%.
- Elimination of Police and Fire DROP.
- New hires in Police and Fire will have a pension multiplier reduced from 2.8% to 2%. They are not eligible for Social Security.

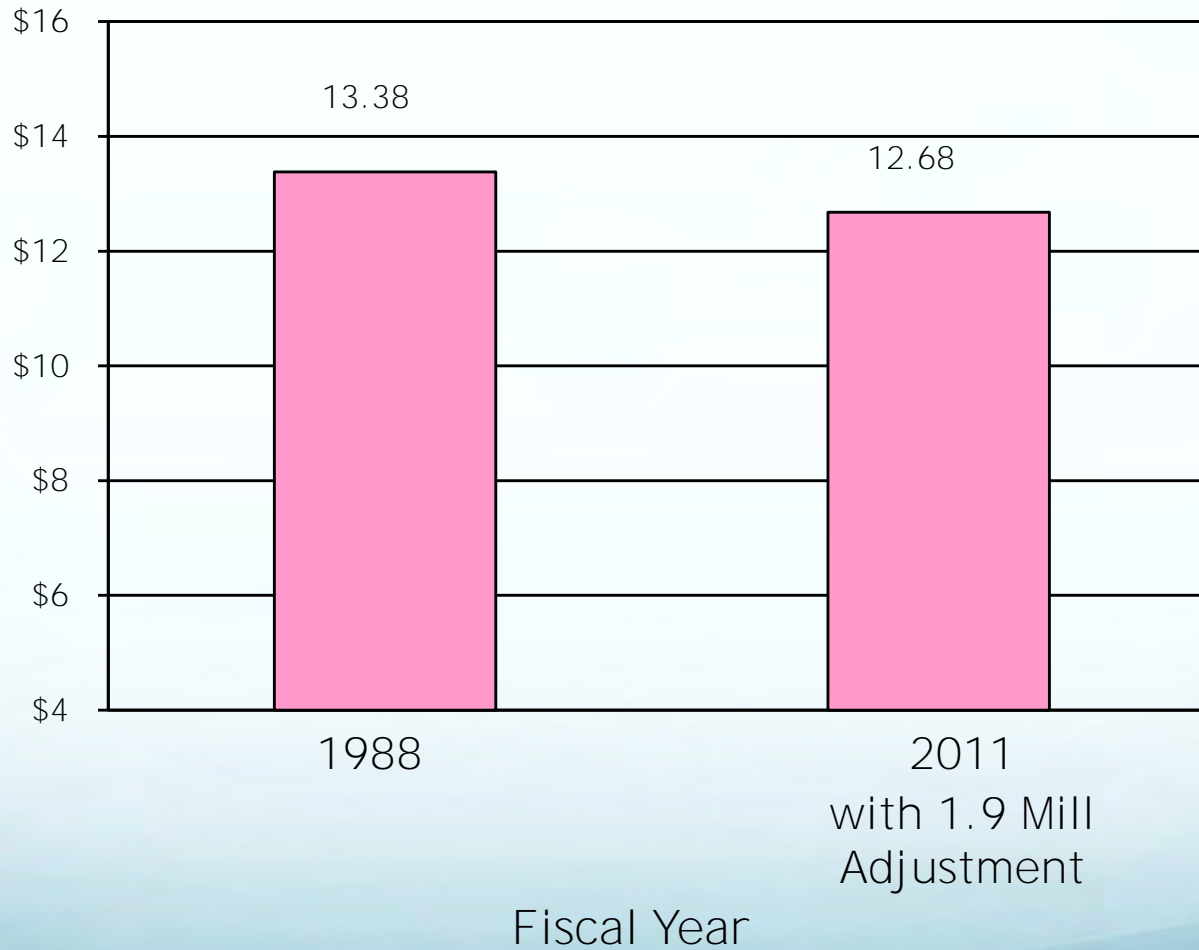

- Defined Benefit will continue to be phased out over time and replaced by the DC Plan. DC Plan started in 1997.
- City contribution has been reduced from 7% to 4% of wages.

Property Tax Comparison

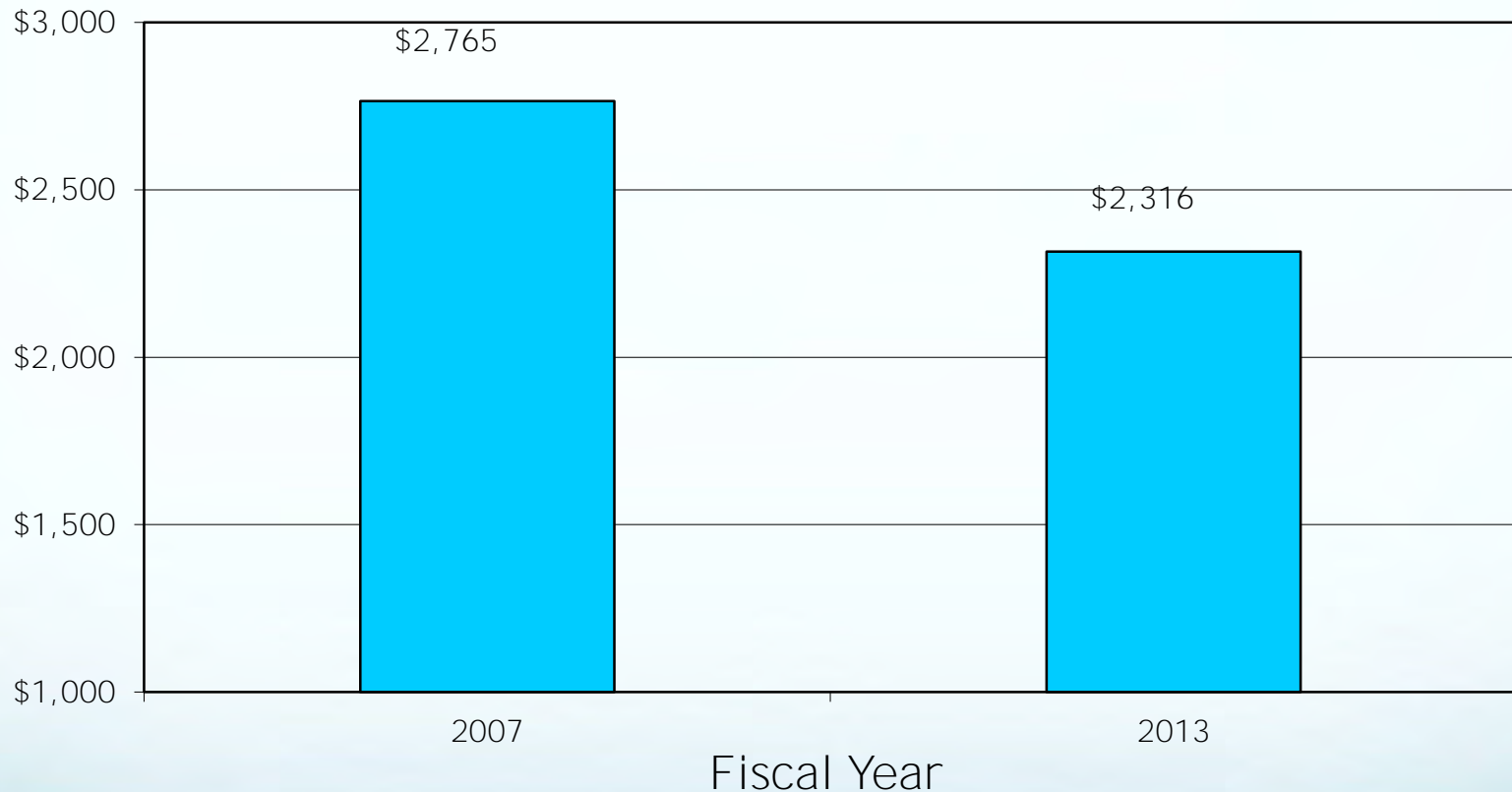

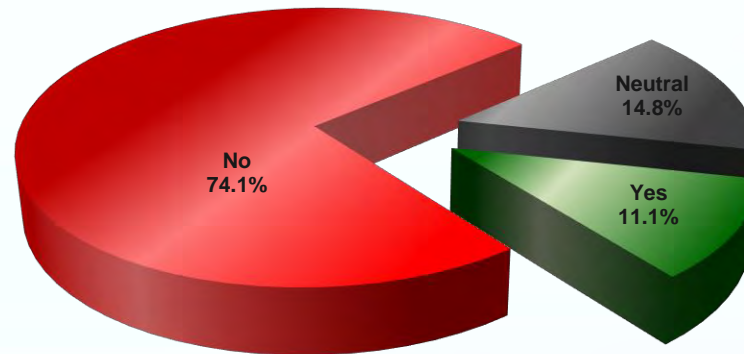
Average Homeowner's Tax Bill Remains Lower Than in 2002

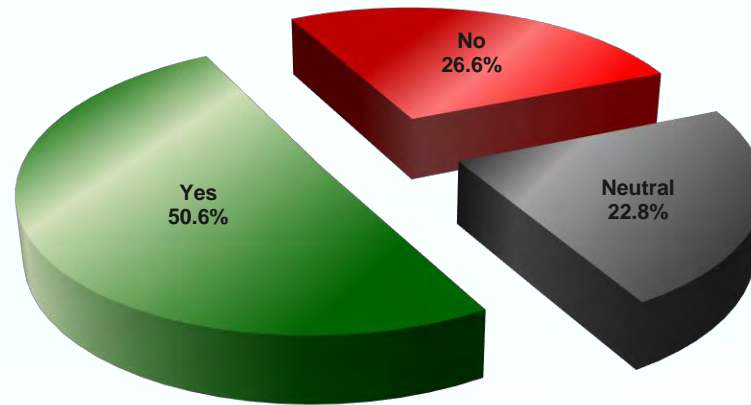

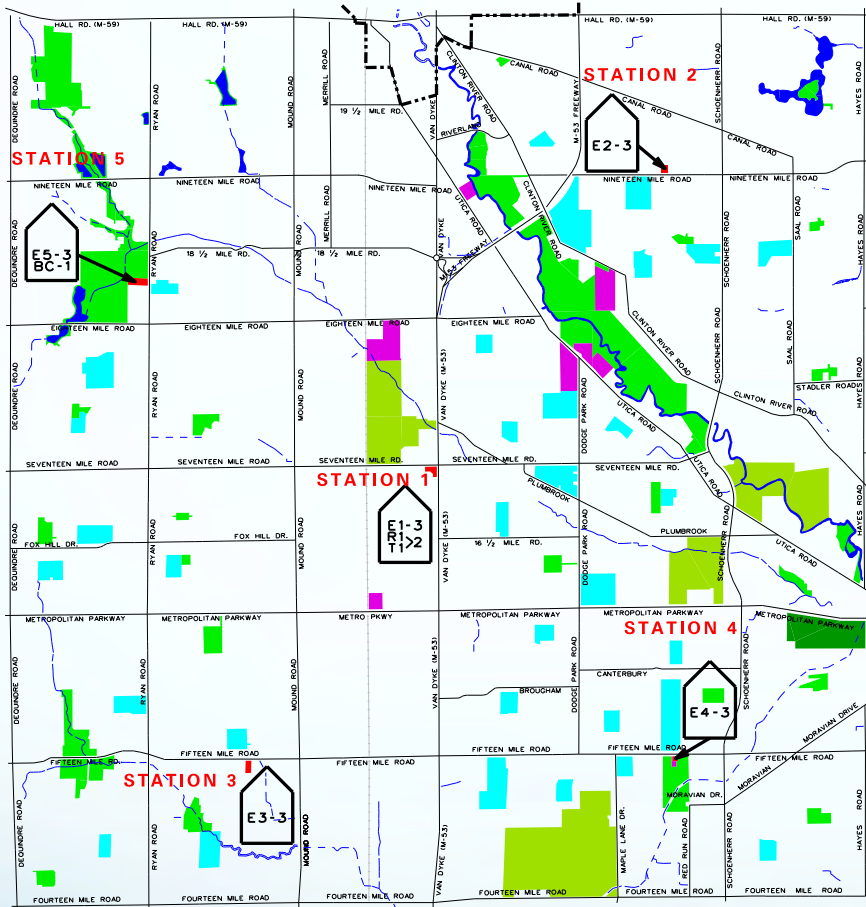

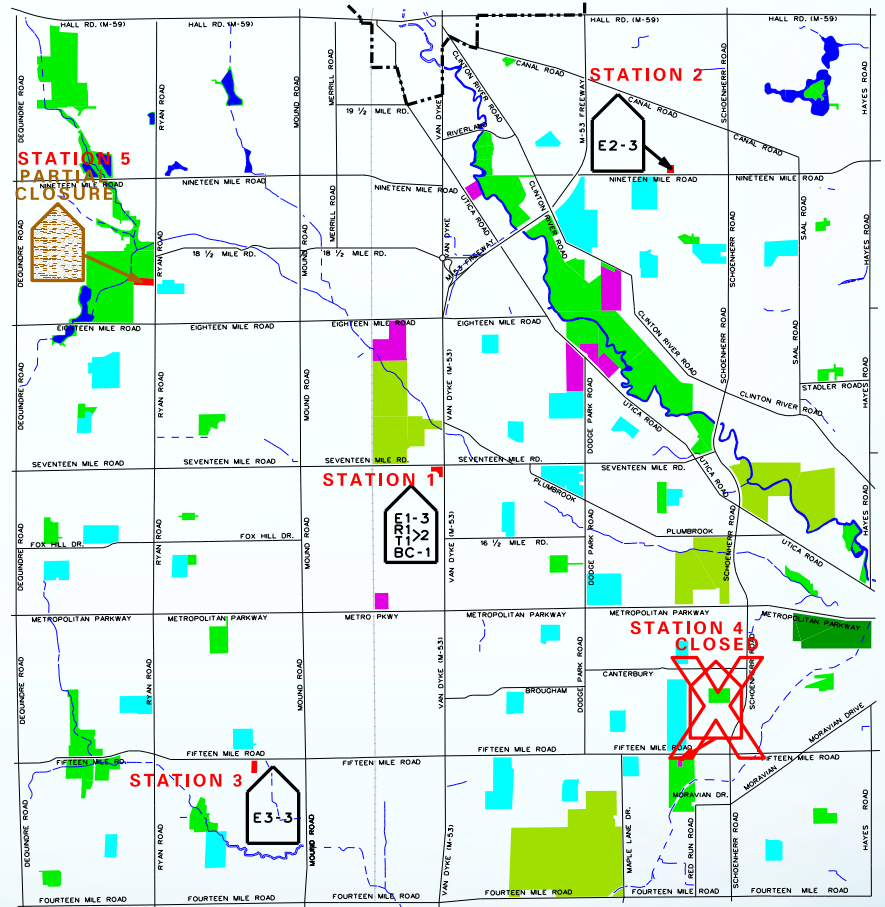

The Bottom Line: What it means to you



As discussed publicly over the past several years, the city can either continue cutting services and positions or seek to recover a portion of lost property taxes to prevent further reductions to public safety. Based on the December 2012 community survey, residents continue to place a high value on public safety and do not want to see further reductions in this area. A majority indicated they would support a public safety millage to avoid further layoffs in public safety.

City administration has determined that 1.7 mills are needed in order to prevent an additional reduction of 65 public safety staff and to adequately fund public safety equipment, thereby avoiding a delay in public safety response times.

Local streets also rated very high on the community survey. To bring most of the city's local streets up to a fair or good rating, the city will need a long-term sustainable revenue source of 0.8 mills a year. This will provide \$3.3 million per year for asphalt resurfacing, concrete repairs, and local street reconstruction.

In total, Sterling Heights will need 2.5 mills per year over the next six years to prevent further cuts to public safety staffing and to repair local streets. If approved, the city's millage rate will remain the lowest of any city in Macomb County.

For the average homeowner, the 2.5 mills will equate to a \$137 annually or \$13 per month increase in their current total property tax bill. However, the average tax bill will be \$292 or 10.6% lower than in 2007.

Shape the future of Sterling Heights



Dear Sterling Heights Resident:

By any measure, the City of Sterling Heights has established itself as a premier Michigan municipality during its nearly 45-year existence. Renowned for quality public services delivered at a low cost to taxpayers, the city's efficiency-based operating model has worked well. Unfortunately, the last six years have proven to be the most financially challenging in the history of this community. The combination of an unprecedented decline in property assessments, continued cuts in state revenue sharing and now the elimination of personal property taxes on manufacturer's equipment have eroded Sterling Heights' revenues at an alarming rate.

The city responded to this looming crisis six years ago with a proactive approach implementing labor savings and legacy reforms in the areas of pension and retiree health care. Sterling Heights has reduced its municipal workforce by 200 full-time positions and cut programming in the library and parks and recreation departments. These cost containment measures have saved more than \$33 million, but still not enough to make up for more than \$50 million in lost revenues! Sterling Heights is now at a critical point in its history.

This fall, Sterling Heights residents will have a chance to shape the future of this city like never before. On Tuesday, Nov. 5 voters will determine if the city should continue to delay necessary road improvements and cut vital services or recover a portion of lost revenue through a dedicated millage to preserve excellent police and fire services and improve neighborhood streets.

If approved, Sterling Heights' **Safe Streets** proposal will provide funding to avoid the loss of 45 police officers and 20 firefighter positions. Improvements will also be made to most neighborhood streets throughout Sterling Heights. The city will continue to be one of the safest in the country with excellent response times and low crime. In addition, quality of life programs offered by the library, nature center and parks and recreation will forego further cuts. Simply put, the city's reputation as a great community to live, work and play will be preserved for future generations. Sterling Heights will still have one of the lowest millage rates in the State of Michigan, continuing its long tradition of low cost government.

Thank you for your continued support of this success story we call Sterling Heights.

Questions & Answers

Q1. Why is the city putting the Safe Streets Proposal before the voters for approval?

A1. From a historical perspective, the City of Sterling Heights has recently gone through the worst economic period in its forty-five year existence. The combination of unprecedented declines in property values, continued cuts in state revenue sharing, and the elimination of the personal property tax has devastated the revenues available to the city to fund public services. Despite deep reductions in city expenditures, including employee layoffs, across the board wage and benefit reductions, and cuts in capital investment, there remains a significant imbalance between available revenues and expenses.

In order to preserve police and fire services at current levels, Sterling Heights needs to recover a portion of lost revenue. In addition, new revenues are needed to address the deteriorating condition of local streets throughout the city. The **Safe Streets Proposal** seeks voter approval of a 2.5 mill increase, allocating revenue for police and fire protection (1.7 mills) and local street improvements (.8 mills). If approved, this dedicated millage can be levied by the city for six years, from 2014 to 2020.

The City Council has made the very difficult financial cuts in order to sustain the city through this difficult period. Additional cuts will dramatically impact the level of police and fire services, which have been a hallmark of Sterling Heights since its inception. Fundamentally, it is left to the residents of this community to decide the future course of the city. **Safe Streets** is a referendum on the future of Sterling Heights.

Q2. What will be the impact on police and fire services and the condition of local streets in Sterling Heights if the Safe Streets Proposal fails?

A2. The city will be forced to eliminate 45 police officers and 20 firefighters. This reduction will occur through a combination of layoffs and not filling vacancies created through retirements.

However, the impact on the community will be more than just fewer numbers of police officers and firefighters. A police department with only 100 sworn officers to police a city of over 129,000 residents will not be able to provide the level of protection and services that has made Sterling Heights one of the safest municipalities in the United States. The Traffic, Youth Services, and Detective Bureaus will be dramatically reduced or eliminated. Response times to 911 calls will increase as police manpower dedicated to street patrol will be reduced by 24%.

On the fire side, the excellent response times of the Fire Department will be negatively impacted as one of the city's five fire stations will close and another station will close for short durations. Depending on 911 call volume, it is projected that the Fire Department's response times will increase from three to ten minutes.

The deteriorating condition of Sterling Heights' local streets is readily apparent to every resident. The state funding mechanism for maintenance, repair, and replacement of local streets is broke and state government cannot agree on how to fix it. Simply put, the local streets continue to get worse and the cumulative cost to remedy the conditions increases. The city has dedicated all available funding to the repair of the worst of its local streets. But the number of local streets in poor condition is growing. If the **Safe Streets Proposal** fails, the condition of the city's local streets will deteriorate as there will not be sufficient revenue to maintain or repair them. This will negatively impact property values and public safety.

Q3. How much will the Safe Streets Proposal cost if it is approved by the voters?

A3. The average homeowner will pay an additional \$157 in city taxes if the **Safe Streets Proposal** is approved. This equates to \$13 more per month or an additional \$43 per year. However, the average tax bill will be \$292 or 10.6% lower than in 2007.

Even with the 2.5 mill increase, Sterling Heights' overall millage rate will be the lowest of any city in Macomb County and one of the lowest tax rates of any city in the State of Michigan.

Q4. Has Sterling Heights considered alternatives to the Safe Streets Proposal?

A4. The city has made significant cuts in personnel, employee wages and benefits and discretionary spending. For example, non-public safety departmental staffing has been cut in half with more than 200 full-time positions eliminated. Unfortunately, further cutting in these departments will not close the structural imbalance. The amount of reductions remaining to balance Sterling Heights' budget must come from police and fire. Before making this level of reduction in public safety, the residents of this community need to weigh in.

Contracting with the Macomb County Sheriff's Department for police services and/or converting to a volunteer fire department are models that assure a decreased level of service for the residents of Sterling Heights. Therefore, these are not viable alternatives to the full-service police and fire protection currently afforded residents. If residents turn down the **Safe Streets Proposal**, the city will have no choice but to implement a decreased level of police and fire service based upon available revenues.

Q5. If the Safe Streets Proposal is approved, will other city departments benefit?

A5. Not directly. However, by stabilizing Sterling Heights' financial condition, all city departments will be spared from further cuts, which have compromised the delivery of quality public services. By eliminating the need to continually cut services, the city can return its focus to the long range planning necessary to ensure quality Public Works, Library, Parks & Recreation, Economic Development and other community oriented services important to our future success.



BALLOT QUESTION

CITY OF STERLING HEIGHTS MILLAGE FOR POLICE AND FIRE PROTECTION AND LOCAL STREET IMPROVEMENTS

Shall the Sterling Heights Charter be amended to authorize the levy of an additional ad valorem millage of not more than 2.5 mills for 6 years, from July 1, 2014 to June 30, 2020, for the purpose of providing revenue for police and fire protection, and local street improvements? This 2.5 additional millage authorization shall be specifically delineated as follows:

- 1.7 mills for police and fire protection
- 0.8 mills for local street improvements

This increased millage authorization will raise an estimated \$10,400,000 in the first year if fully tested.

What is Recreating Recreation?

Recreating Recreation is an initiative to enhance the quality of life for residents by improving upon existing and creating exciting new parks and recreational opportunities within Sterling Heights.

If successful, Recreating Recreation will create the following amenities that will provide residents of all ages and abilities with new ways to connect with the City:

- A new community center to be constructed in the Richard J. Norte City Center. This new 122,000 square foot facility will replace the existing 13,000 square foot recreation center that is over 40 years old and provides an inadequate space to host the myriad of recreational programs delivered by the Parks and Recreation Department. With multi-purpose gyms, dance and fitness rooms, a community room, and multiple meeting spaces, the new community center will be a magnet for drawing residents in for physical fitness and community functions.
- A permanent pavilion in Dodge Park to house the popular Farmers Market in the summer and serve as a cover over a brand new refrigerated ice rink for winter skating enthusiasts.
- An outdoor spray ground in Dodge Park for families to escape the summer heat in a safe and fun water environment.
- A multifunctional skate park to be constructed in the City Center. This will be a great amenity for an age group that traditionally lacks recreational opportunities.
- Enclosed bocce ball courts at the Senior Center which will ensure a comfortable environment for year round play.
- A mini soccer field that will provide a great "pitch" for players of the world's most popular game.
- A dog park in Magnolia Park for man's best friend to enjoy some off-leash time in a dog-friendly environment.



- Construction of a canoe/kayak livery and launch and landing pads along the route of the Clinton River to facilitate access to this previously underutilized recreational resource.
- Development of an option for City residents to have full access to aquatics opportunities, including swimming and water activities.
- Installation of a hike / bike trail linking Joseph J. Della, Jr. Major Park with the City Nature Preserve. The hike / bike trail promises to create a unique recreational opportunity that few communities can match.
- Capital improvements to every neighborhood and major park situated within the City.

These amenities are representative of needs expressed by City residents through surveys, the master plan process, community forums, and social media outlets over the course of many years. As other municipalities have filled these needs for their residents, Sterling Heights is at a quality of life disadvantage.

Why is Recreating Recreation a priority?

As the City approaches the 50th anniversary of its incorporation in 1968, it is necessary and appropriate to have a strategic plan for the future. City leaders, with input from residents and business owners, completed a thorough visioning process, Visioning 2030, that identifies enhancement of the City's parks and development of unique recreational opportunities as critical ingredients to creating a "... vibrant, inclusive community for residents and businesses that is safe, active, progressive and distinctive."

To make this new vision statement a reality, the City must create new ways for its residents and businesses to connect with and develop a passion for the City. Equally important, that positive connection and passion becomes a draw for others to make Sterling Heights their home. The result is a Sterling Heights that is thriving, not declining.

How will the City pay for the Recreating Recreation improvements?

The cost of the Recreating Recreation improvements is estimated at \$45 million. Unfortunately, the City does not have ability to absorb this cost while at the same time maintaining the existing level of quality public services. While the City parks are clean and well maintained, there is no surplus to finance the desired improvements set forth within Recreating Recreation proposal. A dedicated millage of 0.97 mills for a period of 20 years will not only allow the City to construct the Recreating Recreation Improvements, but operate the new facilities. Because the proposed dedicated millage requires an amendment of the City Charter, Sterling Heights voters must approve it. The City Council has approved placing the Charter amendment question on the November 8th, 2016 ballot.

What is the cost of Recreating Recreation for the average homeowner?

The owner of the average Sterling Heights residence can expect to pay an additional \$63 in City taxes if the Recreating Recreation proposal is approved in November 2016. Some homeowners will pay more and some will pay less depending upon the value of their home. If this proposal is approved, the average homeowner's total property tax bill will still be \$137 or 5.0% less than it was nine years ago.

In developing Recreating Recreation, the City has made the effort to ensure that the new parks and recreation amenities are accessible to everyone who is paying for them. So, contrary to many municipalities, there will be no annual membership fees. For certain recreational activities, such as ice skating and kayaking, there will be reasonable rental fees to participate. There also will continue to be customary registration fees for those participating in Parks and Recreation programs.

What are the benefits of public parks?

Parks have the power to transform communities and the people who reside in them. Consider the following evidence:

- An overwhelming majority of Americans surveyed report that they and the communities where they live benefit from local parks. Research further indicates that living near and visiting public parks lowers symptoms of anxiety, depression, and stress, increases the level of physical activity and fitness, and lowers the incidence of obesity, especially in children.
- Local parks generate economic activity and four in five Americans surveyed concur that local parks are well worth the tax dollars spent on them. The value of properties actually increase due to their proximity to a public park.
- Parks and the trees within them remove pollutants and carbon dioxide from the air, prevent flooding, and cool the communities where they are situated.

The Recreating Recreation initiative will leverage the existing natural resource assets to create a City that provides its residents with year-round recreational opportunities. The millage will fund the City's Recreating Recreation initiative that will deliver a diverse mix of recreational opportunities to the City's 130,000-plus residents, including:

- Construction of a new 122,000 square foot Community Center that would be a draw for all residents participating in the wide-array of cultural and recreational programming produced by the Parks & Recreation Department.
- A permanent facility for the highly successful Dodge Park Farmers Market.
- A refrigerated ice-rink for winter enthusiasts seeking a place to enjoy outdoor skating.
- An outdoor sprayground that will provide families with a great place to cool down.
- A multi-use skatepark that will be a unique recreational opportunity for the more adventurous crowd.
- Development of a hike/bike trail linking Joseph J. Della, Jr. Major Park with the City Nature Preserve. This hike/bike trail will, for the first time, allow residents to access the 110+ acre preserve from Della Park.
- A dog park where man's best friends can enjoy some off leash time together.
- Facilities for canoe and kayak enthusiasts to enjoy the best stretch of the Clinton River in Macomb County.
- Capital improvements to nearly every one of the City's 26 neighborhood and 5 major parks.
- Access for City residents to enjoy an aquatics option for year-round water activity.
- A mini turf soccer field for those who enjoy playing the world's most popular sport.

"There is so much potential to develop Sterling Heights as a place renowned for recreational opportunities," said Sterling Heights Mayor Michael C. Taylor. "Creating new levels for our residents to connect with the City is exactly what placemaking strives to do. These new recreational amenities will be destinations for our residents and an attraction for families looking for an outstanding quality of life."

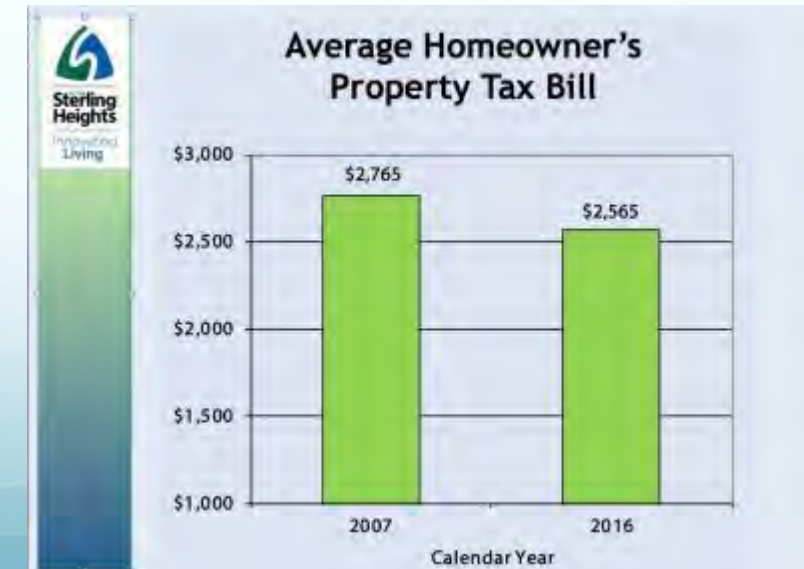

Using Feedback

- What are you hearing at in-person and online forums?
- Are there rumors, misconceptions or items that need clarification?
- Use feedback to pivot and respond when needed
- Pool example: Recreating Recreation plan did not include a pool, but after feedback, the City sought an opportunity with Warren to share facility

Anticipate snags... and re-adjust

- Water rate increase in September 2016 led to outcry
- Removed “VOTE” flyer in water bills for final cycle

Residents get sticker shock on pricier water bills

Sterling Heights residents are expressing outrage over the high costs of their most recent water bills.

During a Sept. 6 Sterling Heights City Council meeting, several public speakers complained about water bills that they say are vastly more expensive than their previous ones.

Sterling Heights resident Giulio Russo called the situation "a total joke."

He compared a current water bill to one that he said was from the same month a year ago with about the same amount of water usage on it.

Approaching the Business Community

- Connect with Chamber of Commerce, DDA and major businesses in the community to begin telling your story
- Set up formal meeting with full presentation
- Ask business leaders to consider public endorsement of millage if they support

What a Business Community Endorsement Means

- Business community pays enormous amount of taxes, specifically manufacturing in Sterling Heights
- A possible endorsement from business community could carry heavy weight with residents and other businesses when considering the measure
- Helps to build open lines of communication, allows city to adjust educational messaging if needed

Lessons Learned

- Consider the timing of your millage (financial outlook, election type, etc.)
- Begin the conversation early, even years before the proposal to take community temperature
- Develop identifiable marketing plan geared to reach residents of all ages, demographics, ethnicities
- Encourage resident engagement through as many forums as possible and use feedback to shape Q&A, messaging
- Remind residents to VOTE! as much as possible as the election draws nearer
