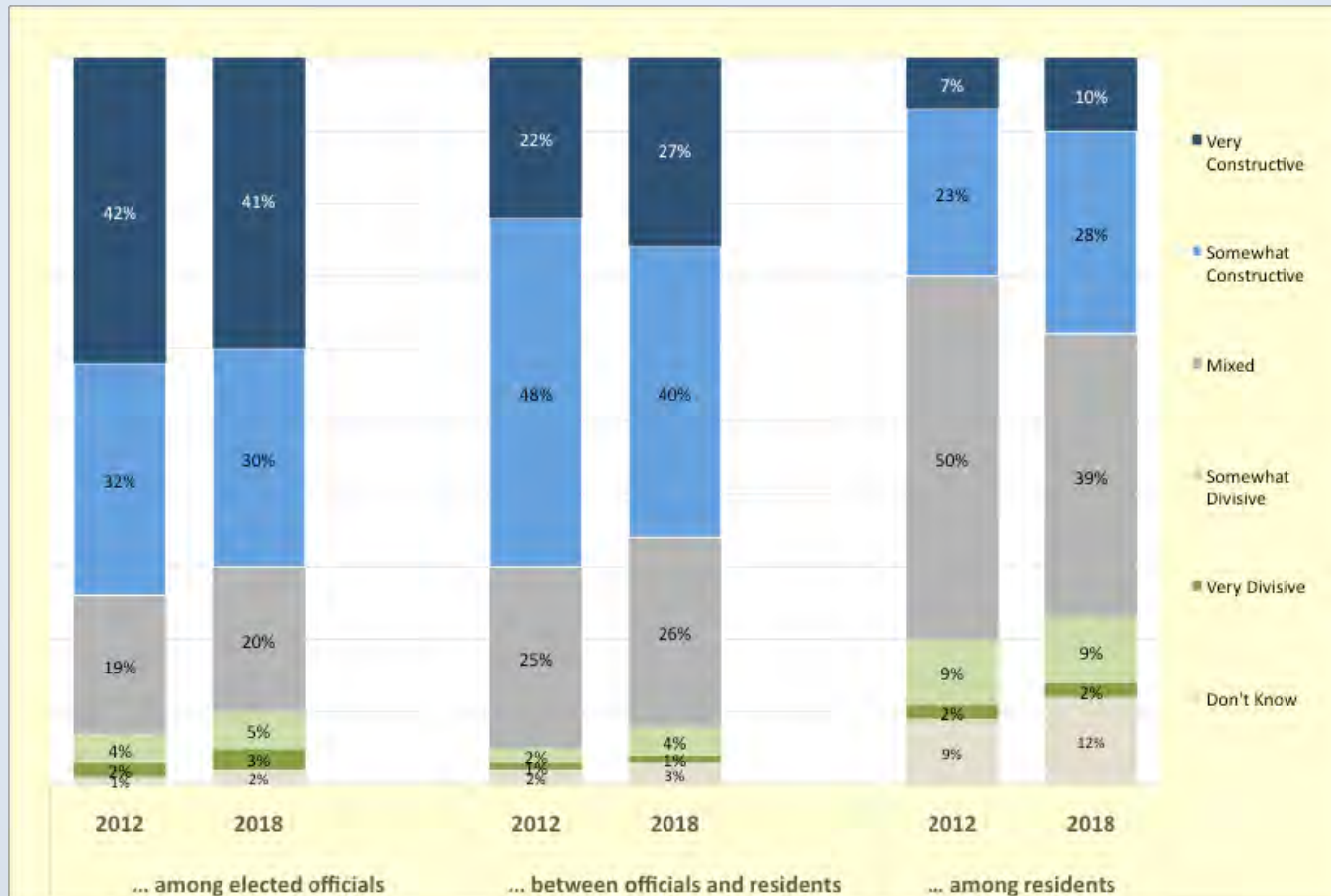

Background: The Michigan Public Policy Survey (MPPS)

- A census survey – all 1,856 Michigan counties, cities, villages, and townships
- Respondents – chief elected and appointed officials
- Administered – since 2009, online and via hardcopy
- 70+% regular response rates (Spring 2018 = 74%)
- Transparency
 - Questionnaires online
 - Pre-run data tables online
 - Sharing of (anonymized) datasets with other researchers
- Expert advisors on questionnaire content
- Research partnership with Michigan local government associations
 - MAC, MML, & MTA

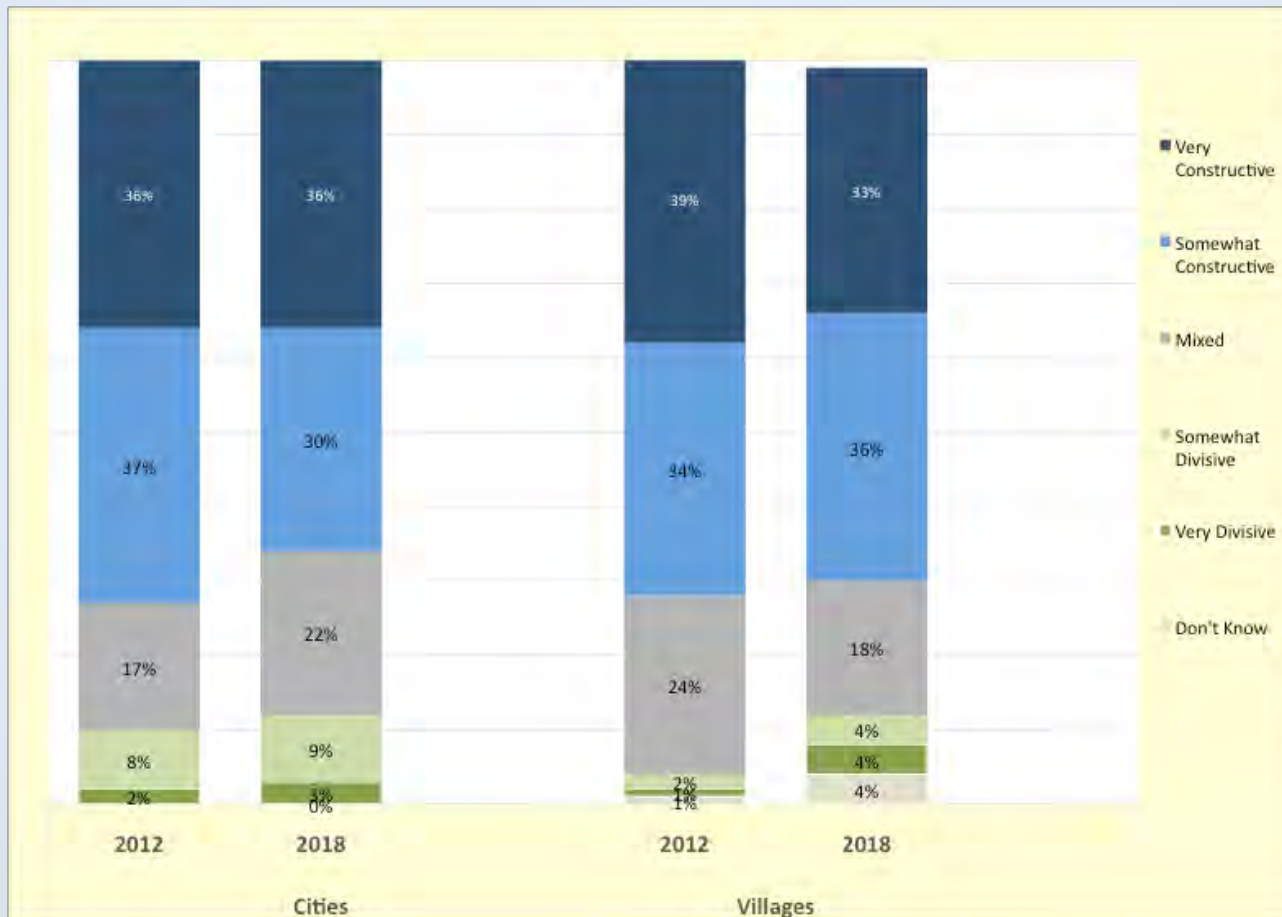

Thinking more generally about the tone of discussion and communication that takes place around local policy issues, how would you describe **the general state of public discourse** between the following groups within your jurisdiction?



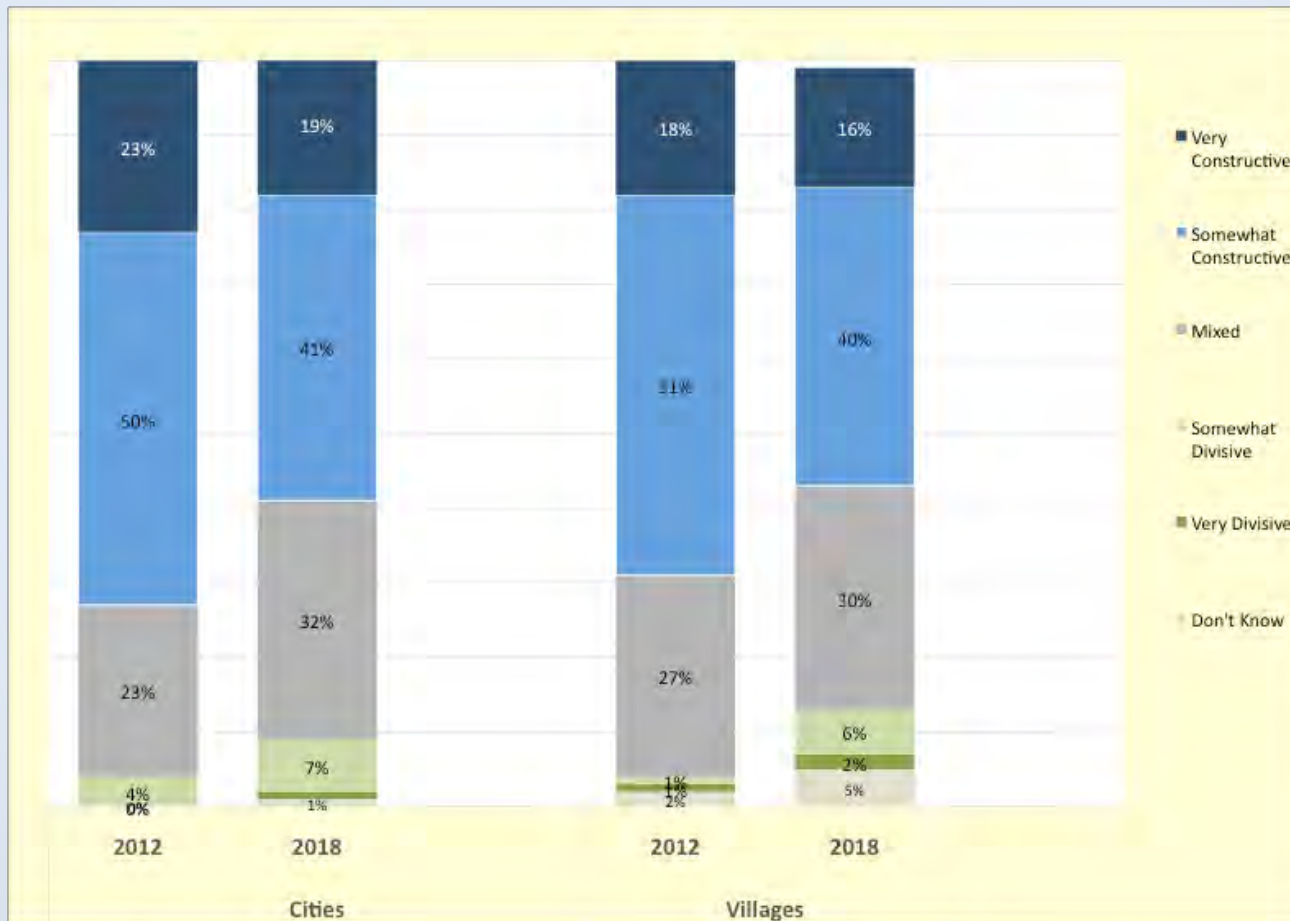

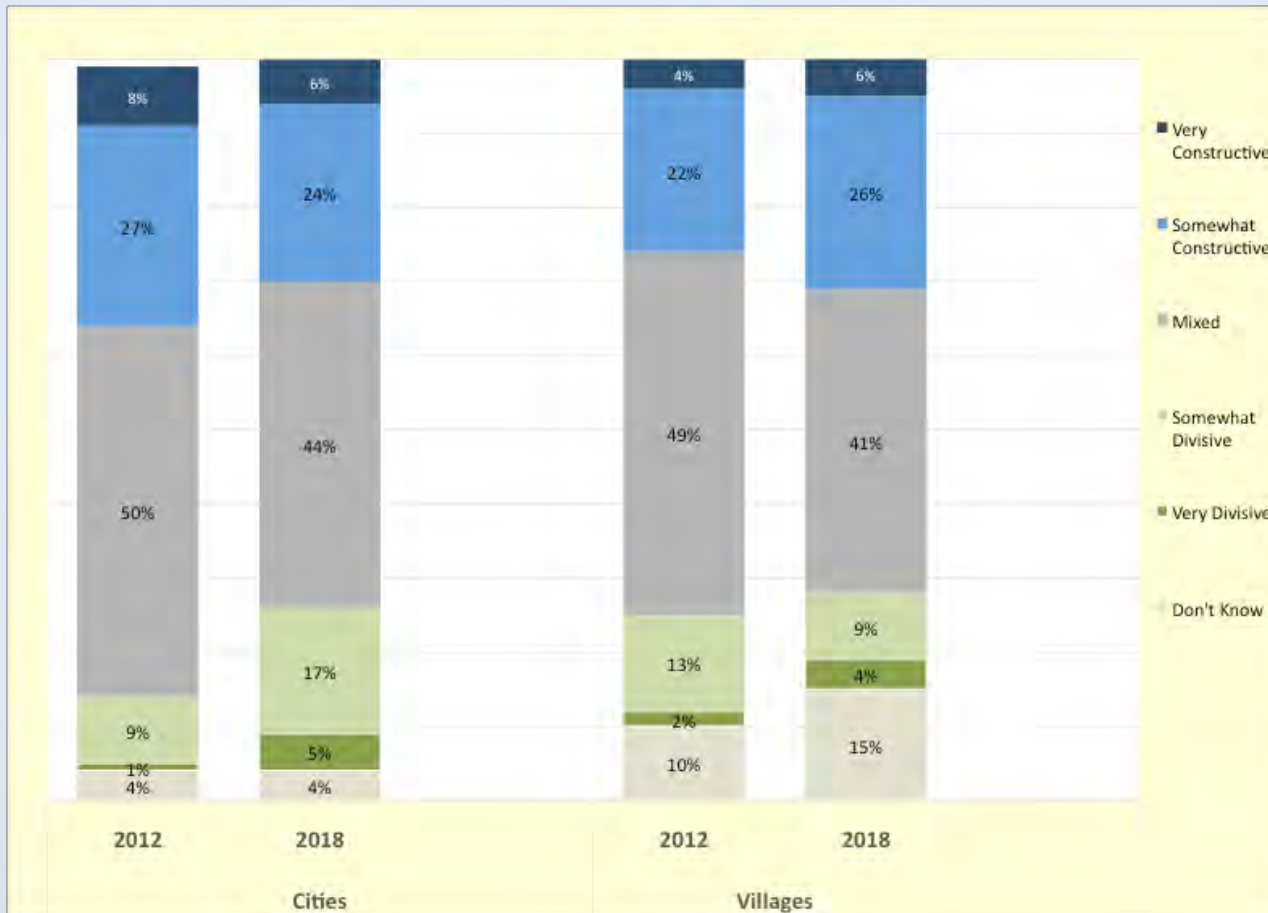
How divisive between city/village officials and residents?

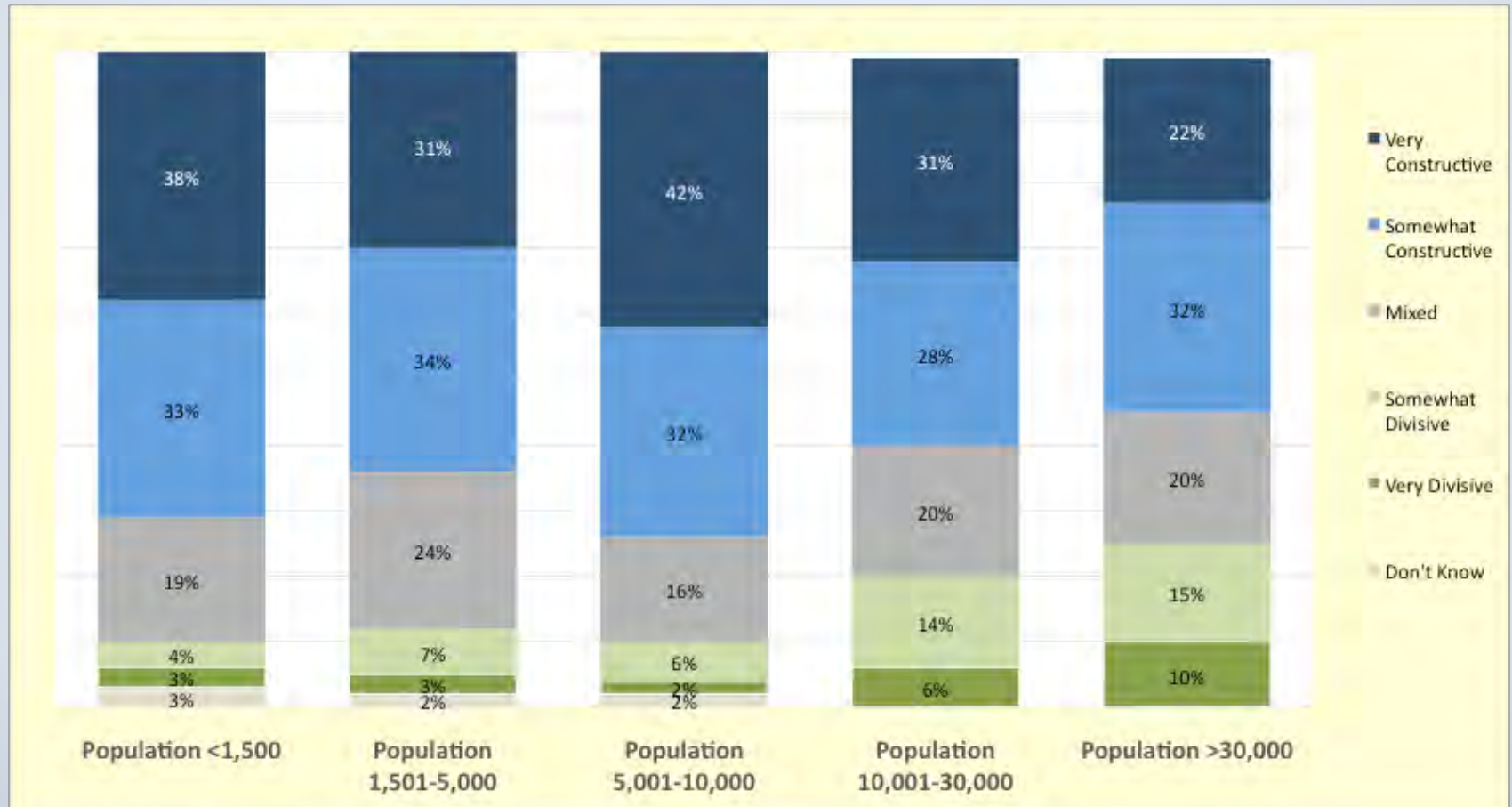
How divisive among city/village residents?

Thinking more generally about the tone of discussion and communication that takes place around local policy issues, how would you describe **the state of public discourse among residents themselves** within your jurisdiction?



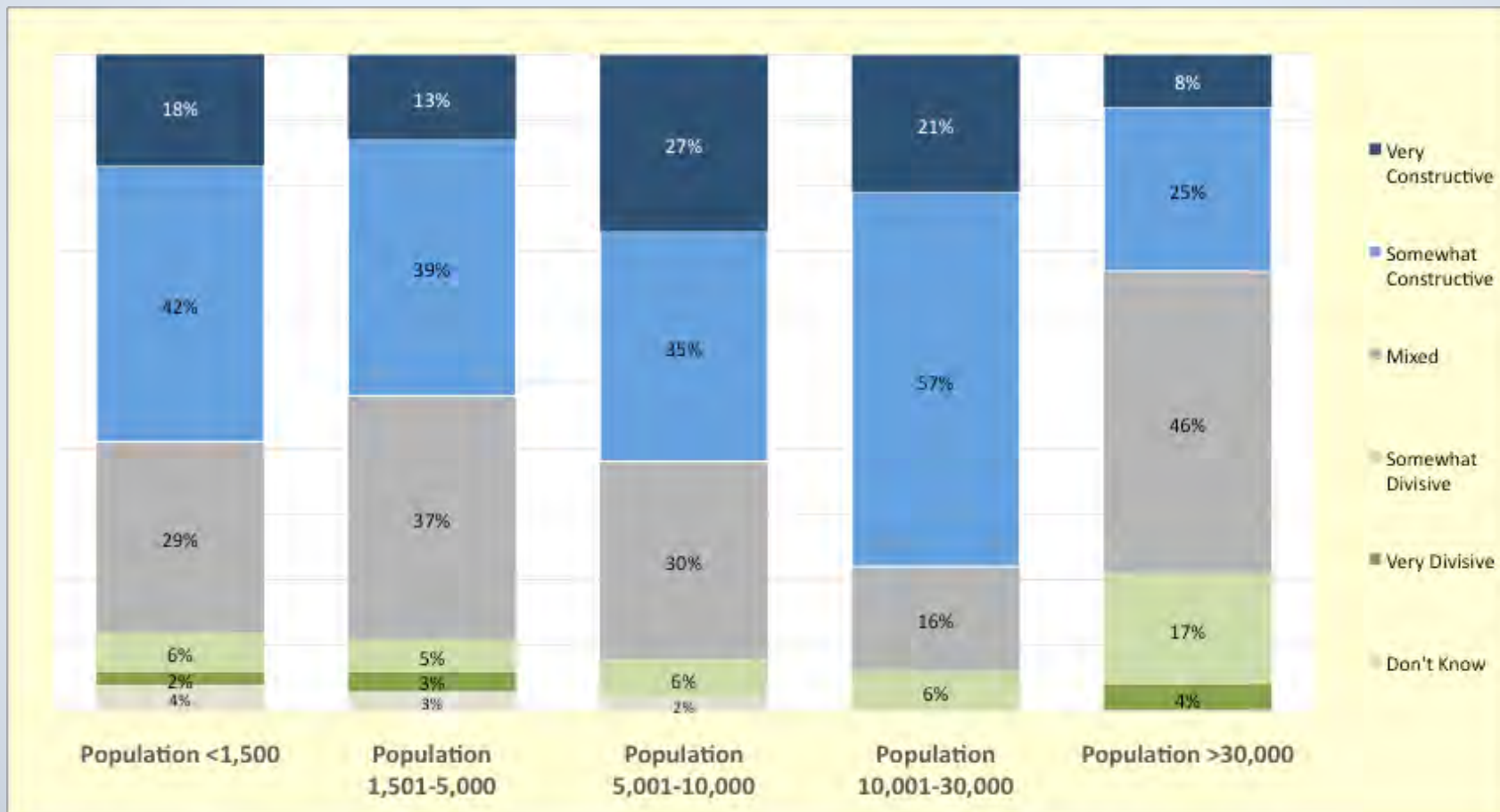
How divisive is discourse among city/village officials?

...how would you describe the state of public discourse among elected officials themselves within your jurisdiction? (2018)



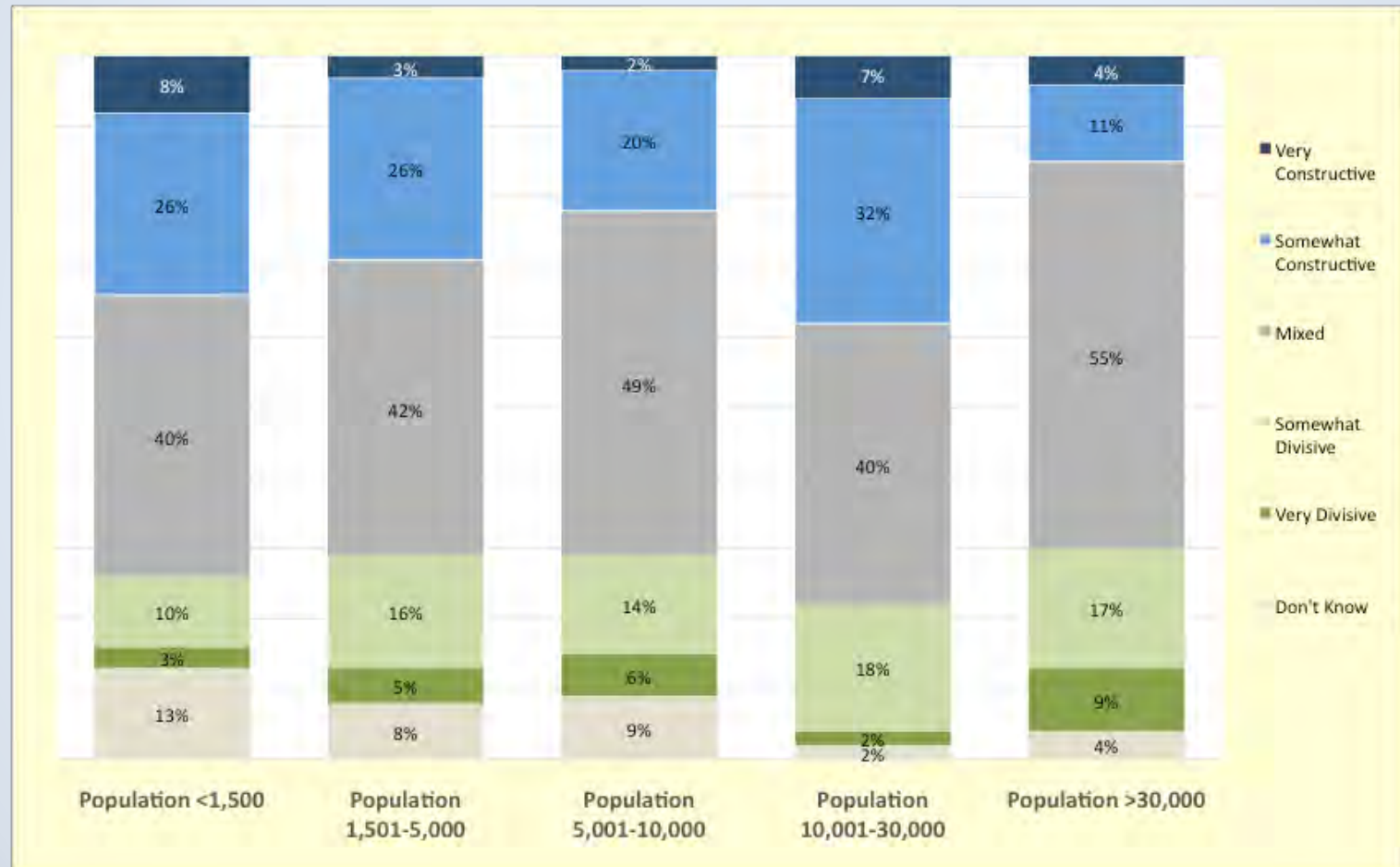
How divisive between city/village officials and residents?

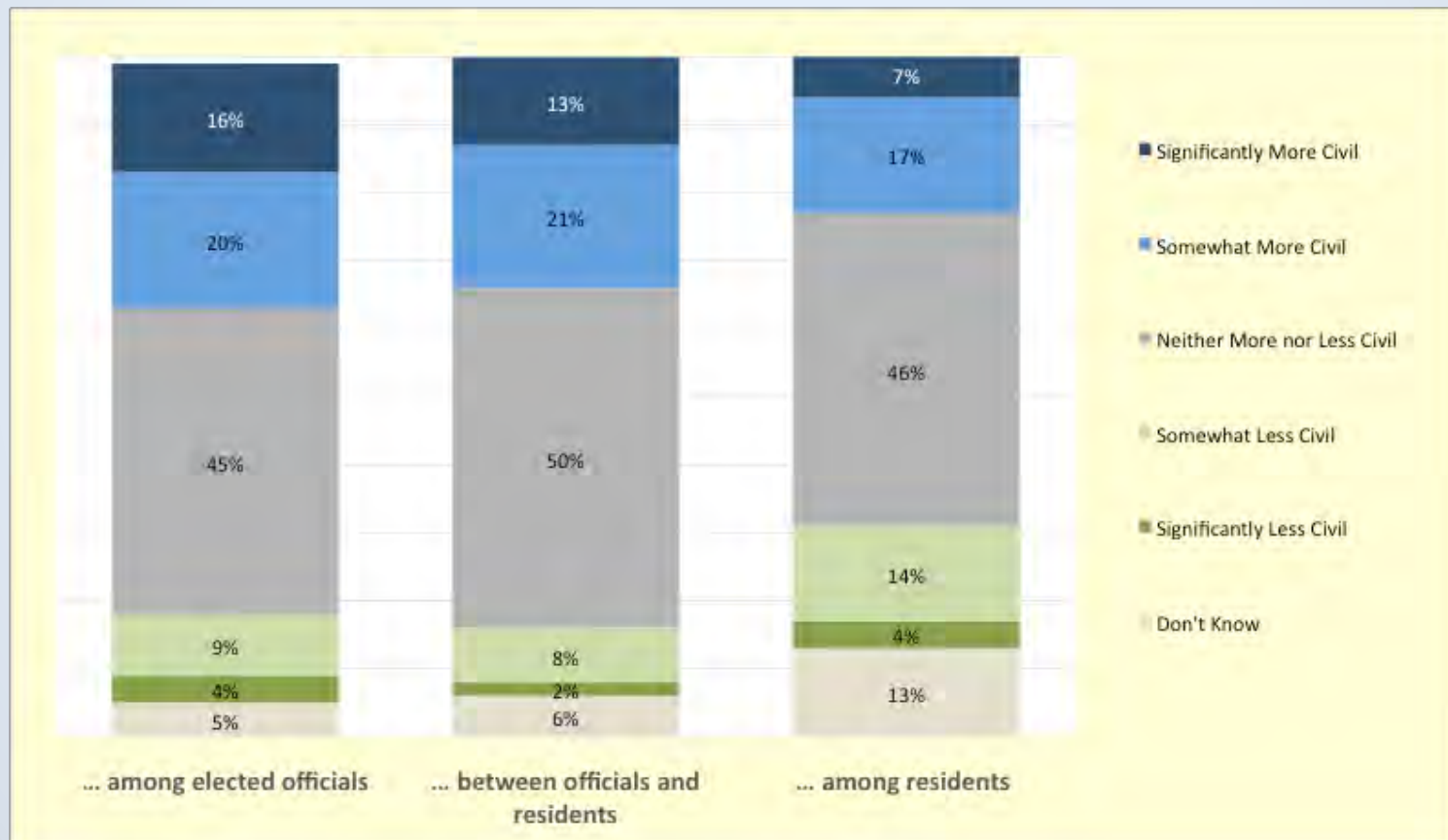

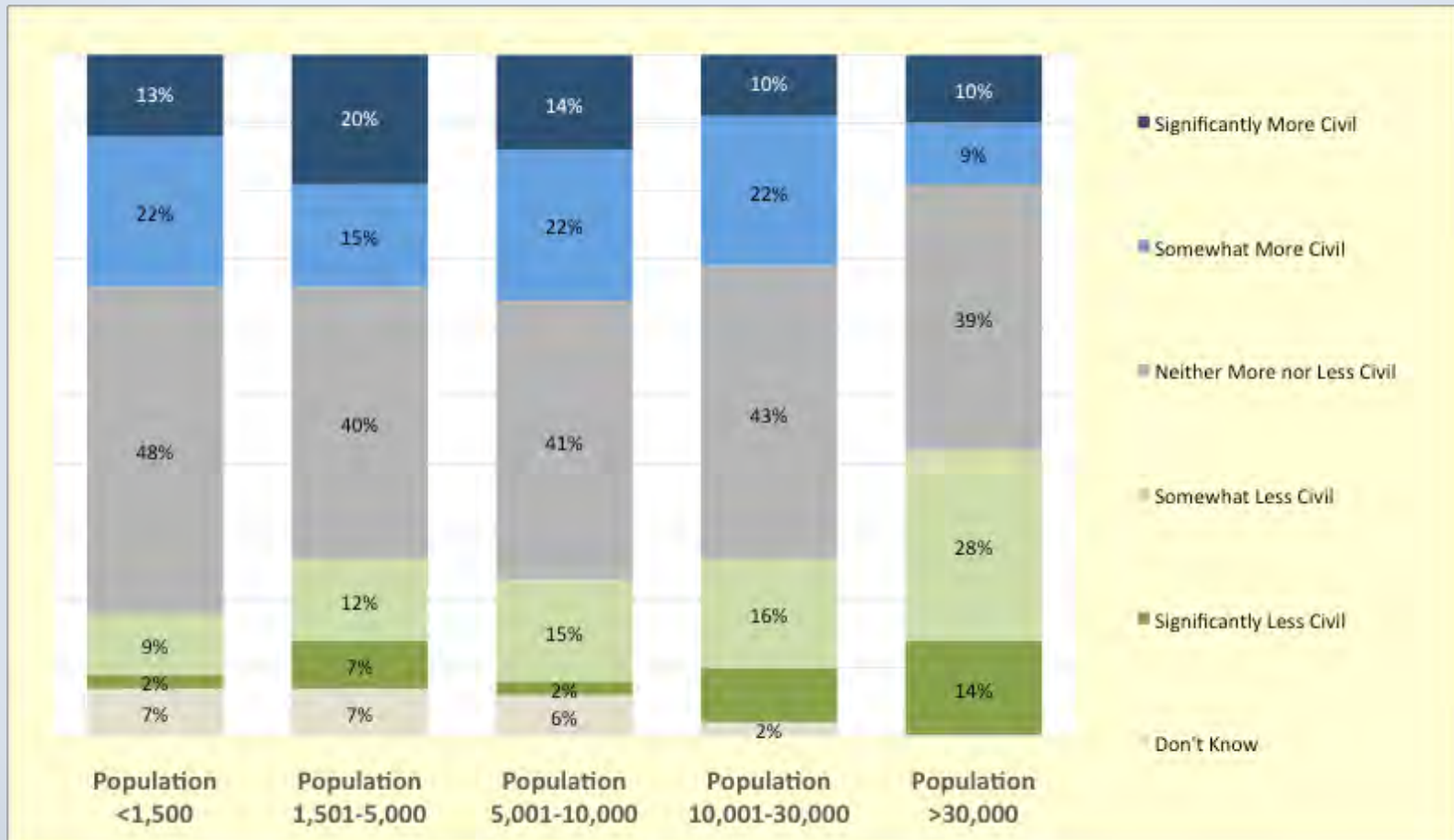
Would you say the tone of discussion and communication among these groups is **more or less civil than it was five years ago?**

Would you say the tone of discussion and communication **among elected officials** is **more or less civil than it was five years ago?**

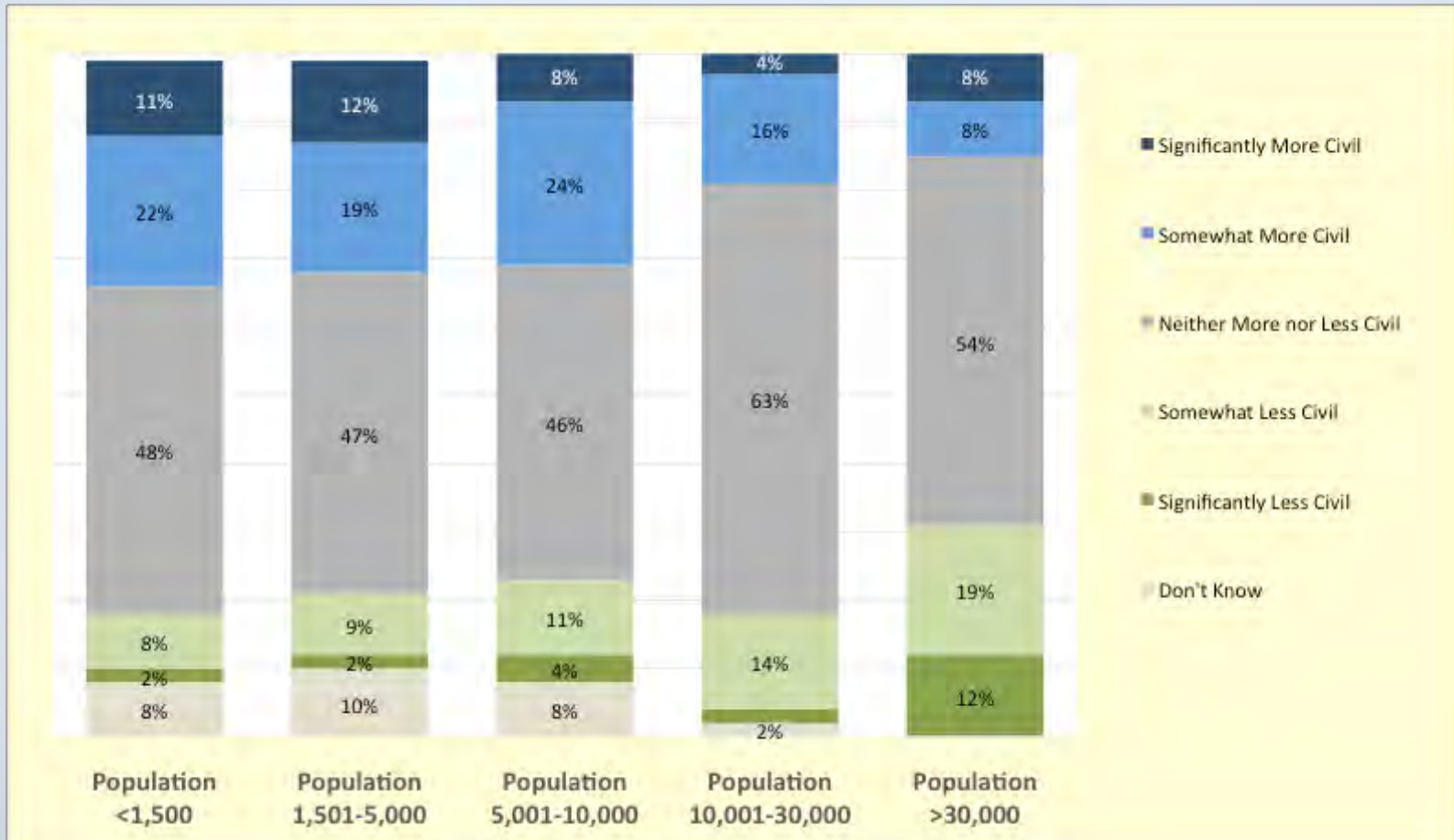

Would you say the tone of discussion and communication among **between elected officials and residents** is **more or less civil than it was five years ago?**

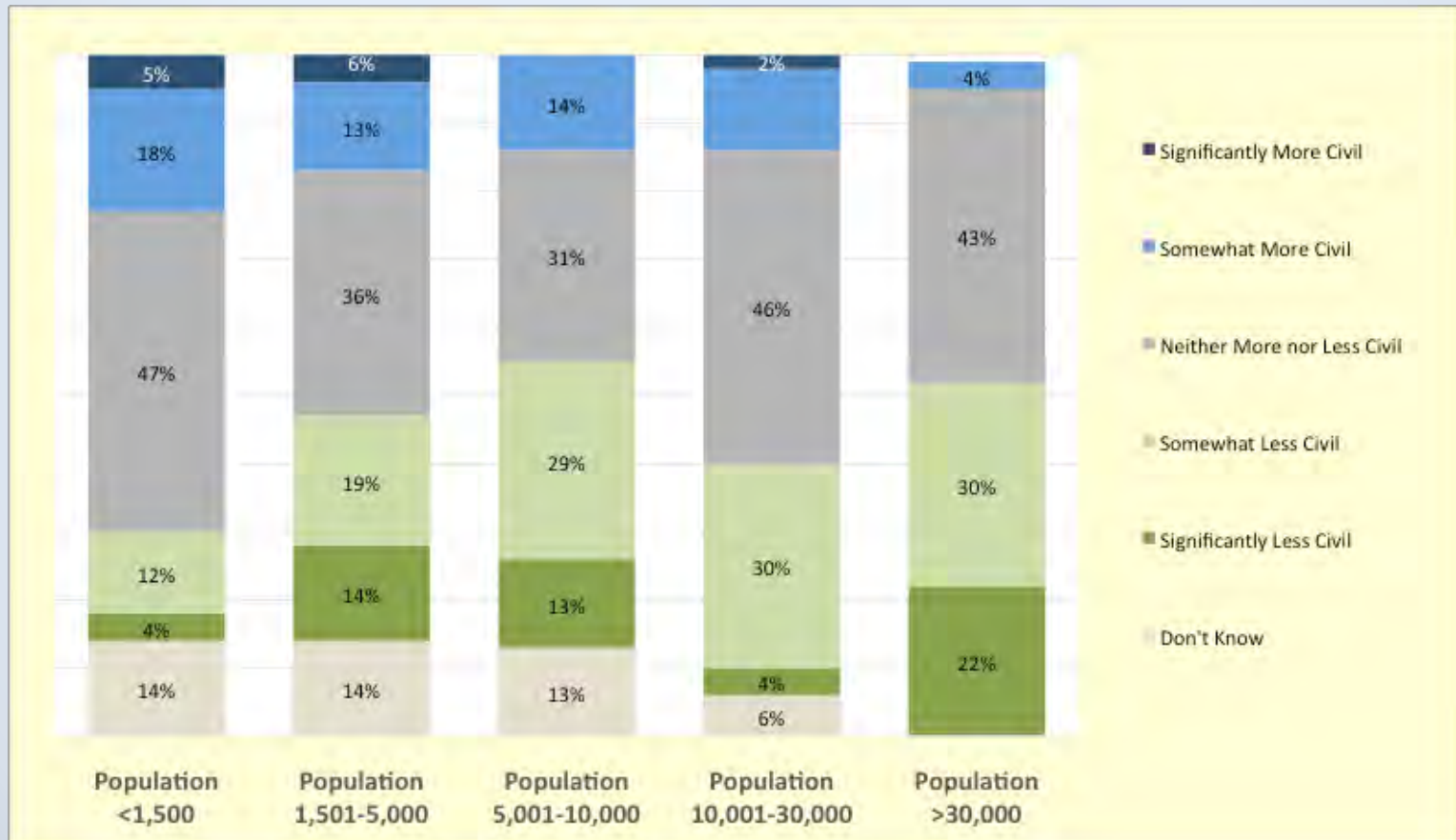
