



Historic Levels of Funding

2020

- 1. Coronavirus Preparedness and Response Act (March) \$.8.3 Billion
- 2. Families First Coronavirus Response Act (March) \$192 Billion
- 3. Coronavirus Aid, Relief, and Economic Security Act (March) \$2.2 Trillion
- 4. Paycheck Protection Program (April) \$483 Billion
- 5. Consolidated Appropriations Act (December) \$900 Billion

Historic Levels of Funding

2021

American Rescue Plan (March) \$1.9 Trillion
 Bipartisan Infrastructure Law (November) \$1.2 Trillion

2022

1. Inflation Reduction Act (August) \$391 Billion

Total Investment: \$7.24 Trillion

A Timeline of Success: Direct and Indirect Investments Benefitting Communities June 2020 – September 2022

Community Invest Starts Immediately

June 2020

- \$100M First Responder Hazard Pay Premiums Program
- \$200M Public Safety and Public Health Payroll Reimbursement Program
- \$60M for Rental Assistance
- \$25M for Utility Assistance

July 2020

• \$150M for Coronavirus Relief Local Government Grant Program

September 2020

- Restore \$97M Cut to Revenue Sharing
- \$35M Increase to Local Roads
- \$5M Historic Tax Credits
- \$800K for Blight Removal in Redevelopment Ready Communities

CARES and ARP Funding Boost State Budget

June 2021

- \$322M Coronavirus Local Fiscal Relief Funds (1st Tranche)
 - Payments Sent to Locals September 2021

September 2021

- \$100M for Revitalization and Placemaking Grants
 - Application Opened Jan 2022, Awards Announced September 2022
- \$168M into State Revolving Funds for Water Infrastructure
- \$196M to Fix 100 Local Bridges
- \$65M in New Funding for Local Roads and Bridges
- \$36M for Low Income Water Assistance
 - Application Opened Jan 2022, Funding Available Through September 30, 2023
- \$14M High Water Infrastructure Grants
 - Applications Opened September 28, 2022, Application Closes November 30, 2022
- \$5M for First Responder Grants
 - Application Closed February 2022, Awards Announced May 2022

March 2022

- \$322M Coronavirus Local Fiscal Relief Funds (1st Tranche)
 - Payments Sent to Local June 2022
- \$46M Hold Harmless for Constitutional Revenue Sharing Payments
- \$1.7B Water Revolving Loan Funds
 - \$750M for Drinking Water (ARP)
 - \$515M for Wastewater (ARP)
 - \$506M Drinking/Wastewater Improvements and Lead Service Line Replacement (BIL)
- \$20M Drinking Water Asset Management (ARP)
- \$250M Capital Projects Fund Michigan Statewide Broadband Service Grant Program

MML and the Coalition for Strong and Prosperous Michigan Showcase Influence

March 2022

- \$100M Housing and Community Development Fund:
 - \$50M Affordable Housing
 - \$50M Missing Middle Housing
 - Round 1: September 2022 December 2022
 - Round 2: Early 2023 September 2024
- \$50M Residential Clean Energy Improvements
- \$200M Local Parks Recreation and Trail Infrastructure Grants
 - \$65M Spark Grant Program
 - Application Opens Monday October 24

July 2022

- \$16M Statutory Revenue Sharing Increase (6%)
- \$750M Local Municipal Pension Principal Payment Grants
- \$48M Community Technical, Managerial, and Financial Support for Lead Line Replacement
- \$27M Environmental Cleanup and Redevelopment Program – Legacy Cleanups

July 2022

- \$75M Blight Elimination Program
 - Proposals Accepted October 1, 2022, to January 31, 2023
- \$13M Arts and Cultural Grants
- \$50M Nonprofit Relief Grants
- \$3M Office of Rural Development

September 2022

 \$7.5M to Enhance Mental Health Services for First Responders and Public Safety Personnel

Election Impact, Ballot Proposals, and Lame Duck

Election 2022

- Redistricting: Will it have an Impact?
- Every Congressional Seat is on the Ballot
- All Three Statewide Offices up for Re-Election
 - Governor, Secretary of State, and Attorney General
- All 38 Senate Seats up for Election
- All 110 House Seats up for Election
 - Over half the House will be new

Statewide Ballot Proposals

- Proposal 2022-1: Financial Disclosure and Term Limits
- Proposal 2022-2: Promote the Vote
- Proposal 2022-3: Reproductive Freedom

Anything Could Happen

- High Alert! Short-Term Rentals (HB 4722)
- \$6 Billion in Unspent Funds
- Tax Cuts/Tax Relief?
- Will They Work on Policy?



Policy: What Are We Tracking In Lame Duck

Tax Policy Issues

- Reimbursement for disabled veterans' property taxes (SBs 783 and 1084)
- Reimbursement for small taxpayer PPT expansion (SBs 1060-1063)
- Solar PILT (SBs 1106-1107)
- Reverse vending machine tax exemptions sales, use & PPT (HBs 6372-6374)
- Revenue sharing trust fund (HBs 6133-6134/SBs 1060-1061)

Election Issues

- Election Reform: Preprocessing
- Consolidated elections (HBs 4530-4533/SBs 130-133/3rd option)
- Removal from office (HB 4885)

Environment Issues

- Statewide septic code (HB 6101)
- Drain code (HBs 6317-6318)
- Solid Waste Rewrite (Part 115) (HBs 4454-4461)

Local Authority

- Sand and gravel mining (SBs 429-431/HB 4875)
- Early warning system (SBs 780 and HB 6296)
- Court funding (HB 5956)
- Automated delivery devices (SB 538)

Local Government

- Open Meetings Act (HB 6283)
- Public Notice Reform (HB 6062)
- Freedom of Information Act (HBs 5921-5925)
- Marijuana Charter Amendment Petitions (HB 6336/6337)
- PA 33, Police and Fire Special Assessments (HB 5248)
